

1. All KOKC contests are open to all residents of the State of Oklahoma KOKC listeners unless specific age is required by type of contest, participating agency or advertiser or by law.
2. Only one (1) qualifier or winner per family within a 30-day period.
3. Winners may be required to sign a release, and all winners agree to allow KOKC to use their name, and/or likeness for promotional purposes without further compensation. All calls coming in to KOKC are taped and may be aired on KOKC without further approval.
4. KOKC is not responsible for problems occurring within the telephone system, which either inhibit or increase the chances of winning a phone-in contest. In the event two or more phone lines are "tie together" during a phone-in contest, the entire call & all callers "tied together" will be disqualified and another caller will be taken. KOKC cannot award duplicate prizes to all parties in a "tied-together" situation. In case of telephone line malfunctions, the decision of KOKC will be final.
5. Employees and agents of Renda Broadcasting and their families, their advertising agencies, or representatives are ineligible to enter contests on KOKC.
